

## TERMS AND CONDITIONS SPRING PRO CAMP 2023 JAIME DE LA PAVA SPORTS CORPORATION

**1. Objective:** Spring Pro Camp 2023 is a cultural exchange event between students linked to sports schools in Colombia and the U.S.A. with Jaime De la Pava Sports Corporation, in which the participants who register will be able to visit the city of Santiago de Cali, Colombia, learn its customs, food, activities, places of interest and the way in which Jaime De la Pava Sports Corporation instructs their soccer players in the practice of soccer/training.

**2. Dates:** The designated dates for the Spring Pro Camp 2023 are March 13<sup>th</sup> to March 18<sup>th</sup> (dates might be subject to change in the event of a major and predictable circumstance)

**3. Player and Guest(s) Responsibility:** With the application and registration for the Spring Pro Camp 2023, you accept full accountability of any injuries associated with the participation of any scheduled sporting events or those associated to scheduled trips, displacements or activities, for which you agree to exempt Jaime De La Pava sports corporation from full responsibility, and the full responsibility thereof by the participants and their legal representatives in case they are minors. By accepting our terms and conditions, you acknowledge that you are aware that travel, wherever and by whatever means, involves some associated risk of injuries, illnesses, death, loss or damage to personal property, which may be caused by natural disasters, negligence or actions of others. In consideration of, and as part of the payment for your participation in Spring Pro Camp 2023 you are voluntarily releasing Jaime De la Pava sports corporation, its employees, assignees, independent contractors, or anyone involved with them, from any damages, liabilities, cost, injury whether mental or physical, known or unknown, and by participating you agree to assume all risks, whether known or unknown.

**4. Age of Participants:** Those under the age of eighteen (18) may register for the Spring Pro Camp 2023, as long as they are accompanied by an authorized adult, parent or legal guardian.

**5. Player and guest responsibility:** You take responsibility for choosing an appropriate activity based on your physical abilities and interests. You personally responsible for being healthy enough to carry out any activities. By accepting our terms en conditions, and deposit, you certify that you are not aware of any physical or other disability that could create a risk to you or other participants.

These terms and conditions apply to event reservations, but do not apply to flight reservations.

**6. Contractual Scope:** The obligations of Jaime De la Pava Sports Corporation will take effect only when the application, registration and payments are validated and accepted by Jaime De la Pava Sports Corporation.
